



MEMBERSHIP RENEWAL goals & requirements 2008

2008 Renewal Goals:

- To clarify the status of each educator who has been involved in BBB from its inception
- To recognize and compensate individual contributions to the company to-date
- To collect dues that support BBB services to its members and as an indicator of commitment going forward
- To add to the body of knowledge and documents available to all educators for use in BBB classes

Requirements due May 31st, 2008:

1. **Portraits:** Complete at least one Portrait of Labor (a birth you personally experienced) and the accompanying narrative. **Cathy Sullivan** will be available, by appointment, to mentor anyone needing assistance in completing their Portraits. She can be contacted through the BBB website from the drop-down menu in the 'Find' section. For those who have already graphed all their labors or have not yet experienced a labor first-hand, your assignment is to assist someone else in completing their Portrait and narrative and submit it. Portrait materials and instructions are available on the Certification page of the BBB Member website.
2. **Sharing:** The renewal process is an excellent opportunity to review what you have developed/plan to develop or resources you have that could be made available to all BBB Educators. This not only benefits fellow BBBEs but also helps BBB see what needs our educators have and potential ways to respond to those needs. Please send in any materials you would like to share along with your renewal packet. **Note:** BBB will not sell any original material submitted by an Educator to the public for profit without notification and proper compensation.
3. **Foundation Packet:** Complete the current foundation requirements expected of all BBBEs going forward (due date for this item extended to **May 31st, 2009.**)
4. **Training Seminar:** Attend a 4-day BBB Training Seminar (held from July 2007 - May 31st 2009); new curriculum materials will be distributed as part of the seminar. Members must hold active status in order to attend the Training Seminar. Through May 2009, there will be no charge for the Training Seminar and new curriculum materials for those who attended the June/November 2006 meetings.
5. **Educator Agreement:** Sign and return.
6. **Membership Dues:** May be paid via check or paypal to info@babybodybirth.com
 - Active Status:** Submit \$125 (along with requirements 1-3 above) to maintain Active Status, which includes:
 - A dynamic web page on the BBB website (instant changes to schedule, bio, contact information, etc.)
 - Inclusion in zip code search for "Find an Educator"
 - Access to Updates, the Forum and Certification sections of the BBB Member website; Curriculum and Marketing sections will also be available for Active members who have completed certification by attending a Training Seminar in 2007-2008
 - Receipt of any newly published physical materials for classes (i.e. BBB Anatomy Poster)
 - Inactive Status:** Submit \$25 (along with requirements 1-3 above) hold Inactive Status, which includes:
 - A static web page so former clients and contacts can reach you (found via the Contact page of the BBB website)
 - Access to Updates, Resources, the Forum and Certification sections of the BBB Member website
 - A dispensation of training fees upon returning to Active status at a later date. Full certification and Active status will be conferred once pro-rated dues (for the part of the dues year you are requesting Active status) are received and any other requirements are completed.
